

Information for Human Ecology Students Seeking Family and Consumer Sciences Education Licensure FCSED

Family and Consumer Sciences Education is a teaching licensure program approved by the Kansas State Department of Education. Although students are enrolled in the Bachelor of Science Degree program in the College of Human Ecology for the duration of their undergraduate program, completion of the program is dependent upon their admission to teacher education in the College of Education. Admission to teacher education is dependent upon the fulfillment of the following requirements:

Please note that applications are accepted at any time, but the deadlines above must be met for pre-enrollment purposes.

1. We now require a **Basic Skill Test** that will help us gather data on your likely success in our program. This online assessment is provided on the Learning Express Library for you without charge. The test includes sections on Reading, Writing, and Math. See <http://coe.ksu.edu/csps/praxis-core.html> for instructions.

3. *DED 075, Orientation to Teacher Education at KSU must be successfully completed.
4. Minimum of 50 credit hours completed, includes all KSU and transfer credits.
5. Expository Writing I and II completed with a minimum grade of "C" in each course.
6. Public Speaking I or IA completed with a minimum grade of "C".
7. Six credit hours in Mathematics with minimum grades of "C", including College Algebra or a higher-level math course, and a statistics course (STAT 325 or above).
8. Minimum 2.75 GPA in all attempted courses that meet degree requirements, including KSU and transfer credit.
9. A minimum 2.75 GPA is required in all college work attempted in the required Teaching Field Courses, including KSU and transfer credit.
10. *Completion of EDSEC 230, Early Field Experience.
*Provisional admission may be granted if the student is currently enrolled or pre-enrolled in the course. Successful completion of the course is required or the student will be dropped from the Teacher Education Program.

Upon admission to teacher education a minimum 3.00 GPA is required in all college work attempted in the Professional Education Courses, including KSU and transfer credit.

Students are recommended for a Kansas Teaching License with an endorsement in Family and Consumer Sciences when they have:

- Completed all of the family and consumer sciences licensure requirements.
- Successfully completed the Principles of Learning and Teaching Test (www.ets.org/praxis/ks)
- Successfully completed the PRAXIS II content assessment for FACS with a passing score. (www.ets.org/praxis/ks)
- Submitted the application to the KSU College of Education Licensing Officer in Bluemont Hall 013 one month before graduation from Kansas State University <http://coe.ksu.edu/csps/licensure/> .
